Dallas Afterschool Network ensures that low-income students have access to safe and enriching afterschool experiences by providing afterschool and summer programs with staff training, program resources and support. Our goal is to help local sites achieve national quality standards, as only high quality afterschool programs change student lives. Children who attend average or low quality programs show no difference in academic, social or emotional outcomes than children who are unsupervised afterschool. Today, DASN supports 165 free afterschool sites serving 12,300 K-12th grade students in Dallas County. Our clients range from national organizations like the YMCA to school based programs like Big Thought and Dallas ISD, to local programs such as Trinity River Mission and Wilkinson Center.
